# Articles of Incorporation

### Article I - Name

The name of this corporation is JASON BLYDEN COMPANY.

### Article II - Effective Date and Duration

This corporation shall begin existence as of the date of filing with the Secretary of Sate and continue perpetually unless dissolved.

# Article III - Purpose

This corporation is organized for the purpose of transacting any lawful business.

## Article IV - Common Stock

This corporation is authorized to issue ten million shares of no par value per share common stock.

# Article V- Authority

This corporation has the authority to conduct any and all lawful business which can be legally conducted by any corporation.

# Article VII - Incorporators, Officers and Directors
