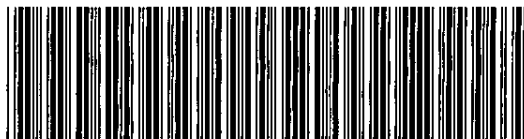


ARTICLE X – AMENDMENT


