ARTICLES OF INCORPORATION

OF

GARY HOLZHAUSEN, IV, P.A.

natural person competent to he State of Florida, hereby

The undersigned subscriber to these Articles of Incorporation, a natural person competent to centract and legally authorized to practice the profession of law in the State of Florida, therefly proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is: GARY HOLZHAUSEN, IV, P.A.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the Corporation is 4130 Tamiami Trail North, Naples, Florida 34110 and the mailing address of the Corporation is P.O. Box 10852, Naples, Florida 34101.

ARTICLE III - PURPOSE

The purpose of the Corporation and the nature of its business are as follows:

- 1. To engage in the practice of real estate sales associate as a professional service corporation and to provide services incident thereto.

The Corporation is authorized to issue one hundred (100) common shares of stock. None of the shares of the Corporation may be issued to

• anyone other than an individual who is a duly licensed real estate sales associate in the State of Florida and is an active member of the Department of Business and Professional Regulation in good standing.

ARTICLE V - PAR VALUE

The shares of the Corporation shall have a par value of \$1.00 per share.
