# ARTICLES OF INCORPORATION

OF

## ROYAL RETREAT ASSISTED LIVING.INC

ARTICLE I

NAME: The name of this corporation is;

ROYAL RETREAT ASSISTED LIVING, INC

ARTICLE II

The general nature of the business to be transacted by this corporation shall be: (a) To provide Health Care services such as three qualified employees to provide and Assisted Living Health Care Services to facilitate same.
