The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be INDEPENDENT PARALEGAL SERVICES, INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be 3111 SW 27 Lane, Miami, Florida 33133.

ARTICLE III

This corporation's existence shall be effective on the date of subscription of these Articles, and the corporation shall have perpetual existence.
