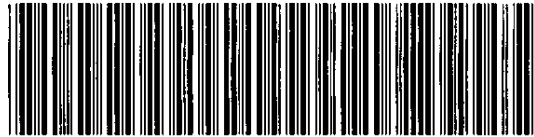

Competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I
NAME OF CORPORATION

This corporation may engage in or transact any of all lawful activities of business
