The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation is **ALWAYS ON TIME AND AFFORDABLE PLUMBING, INC.**

**ARTICLE II - DURATION**

This corporation shall have a perpetual existence, commencing on the day of filing these Articles of Incorporation with the Secretary of State.

**ARTICLE III - PURPOSES**

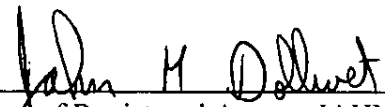

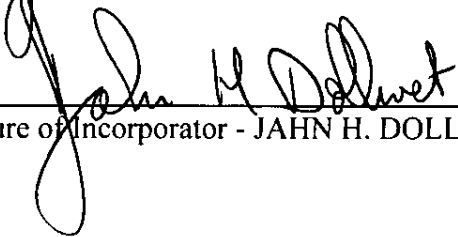
#### **ARTICLE IX - AMENDMENT**
