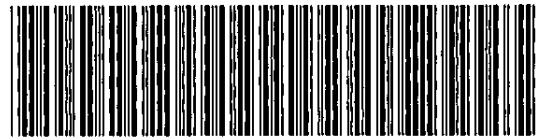

2. This amendment is submitted to amend the following paragraphs:

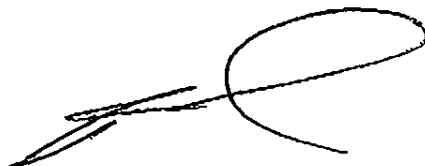
(A) Paragraph 1.1 of Article I of the Articles of Incorporation by deleting the same and substituting the following:
