Name of Corporation

The name of this corporation is MICK NURSERY INC.

ARTICLE II



These articles may be altered, amended or repealed and new articles may be adopted at any regular or special meetings of the Board of Directors and ratified by the majority of the shareholders.



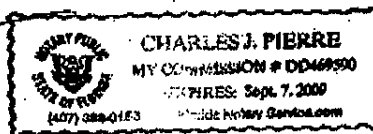
