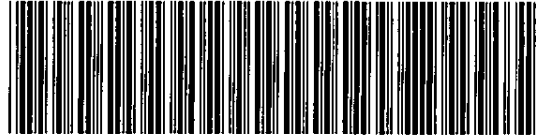

The name and title of this Corporation shall be R.H.K. ENTERPRISES, INC.

ARTICLE II.

The Corporation's purpose is to engage in any lawful business activity for which corporations may be formed under Florida Corporation Law in accordance with F.S, Chapter 621, as amended.

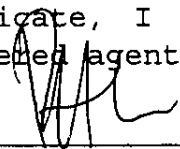
ARTICLE XIII.
