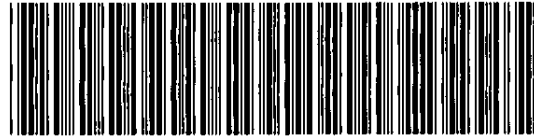

The undersigned duly authorized persons, on behalf of Brooklyn Water Bagel Co.No.1, Inc., a Florida corporation (the "**Converting Corporation**") and Brooklyn Water Bagel No. 1, LLC, a Delaware limited liability company (the "**Converted Entity**"), respectively, and for the purpose of converting the Converting Corporation from a Florida corporation into a Delaware limited liability company pursuant to §§ 607.1112 through 607.1114 of the Florida Business Corporation Act (the "**FBCA**") and § 18-214 of the Delaware Limited Liability Company Act (the "**DLLCA**"), certifies that:




