AMENDED AND RESTATED ARTICLES OF INCORPORATION OF KIMMINS ABATEMENT CORP.



The Amended and Restated Articles of Incorporation of Kimmins Abatement Corp., a Florida corporation incorporated under the provisions of the Florida Business Corporation Act (the "Act"), shall read in their entirety as set forth below:

ARTICLE 1 Name

The name of this corporation (hereinafter called the "Corporation") is: Kimmins Abatement Corp.

ARTICLE 2 Duration

The duration of the Corporation shall be perpetual.

ARTICLE 3 Principal Office and Mailing Address

The street address of the principal office and the mailing address of the Corporation is 1501 E. 2nd Avenue, Tampa, Florida 33605.
