**ARTICLES OF INCORPORATION
OF
CHOICE RECYCLING SERVICES OF BROWARD, INC.**

The undersigned, acting as Incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby causes to be delivered the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be Choice Recycling Services of Broward, Inc. (hereinafter, the "Corporation").

**ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS**
