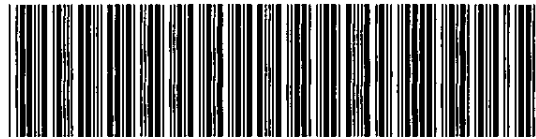

Out a meeting.


The Directors and stockholders of this Corporation may take action by written consent, as provided by law and the By Laws of the Corporation.

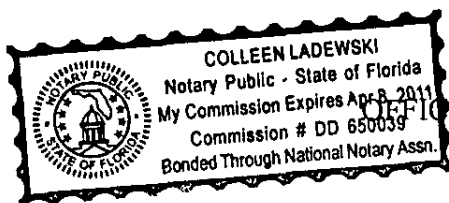
