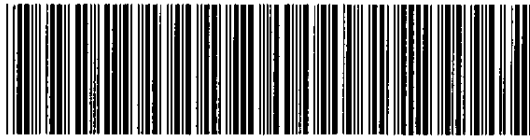

ARTICLE I. NAME

The name of this corporation is CONTRACTING & CONSULTING, INC.



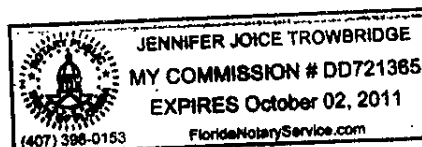
