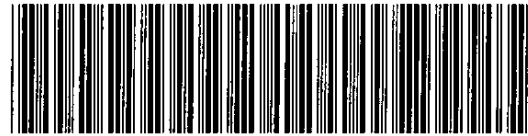

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME**

The name of the corporation is:

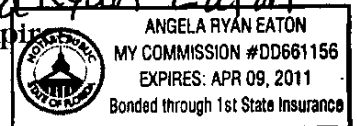
