

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is: **Bedoya Imports Inc.**, and its principal office or place of business shall be located at: **1531 NW 3rd Street, Suite 10, Deerfield Beach, Florida 33442.**

ARTICLE II - DURATION
