ARTICLE I - NAME

The name of this corporation is PATRICIA GIENAU-MARTINEZ, LMFT, P.A., (hereinafter, "Corporation").

ARTICLE II - PRINCIPAL PLACE OF BUSINESS ADDRESS

ARTICLE III - PURPOSE


ARTICLE X-SHAREHOLDERS MEETING REQUIRED


