

ARTICLES OF INCORPORATION

OF

FLORIDA STUDY HALL GROUP, INC., a Florida Corporation

1, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating, a corporation under the laws of the State of Florida.

ARTICLE I NAME and PRINCIPAL OFFICE

The name of this corporation shall be FLORIDA STUDY HALL GROUP, INC., a Florida Corporation, and the principal place of business of this corporation shall be 14245 SW 180TH TERRACE, MIAMI, FLORIDA 33177.

ARTICLE II DURATION

This corporation shall commence its existence immediately upon the filling of these Articles of incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE IV CAPITALIZATION

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the corporation.

Upon the sale for cash of any new stock of the same kind, class or series as that which he

already holds, every shareholder of this corporation shall have the pre-emptive right to purchase his pro-rata share thereof at the price which it is offered to others, whether or not in excess of par. Fractional shares need not be issued on account of this provision.

ARTICLE V INITIAL REGISTERED OFFICE AND REGISTERED AGENT
