# ARTICLES OF INCORPORATION OF CLERMONT PEDIATRICS, P.A.

The undersigned, acting as incorporator, a natural person competent to contract and a Doctor duly licensed to render services as such under the laws of the State of Florida, hereby forms a corporation for profit pursuant to the Professional Service Corporation Act. The corporation shall exist under the laws of the State of Florida and shall adopt the following Articles of Incorporation:

### <u>ARTICLE I - NAME OF CORPORATION</u>

The name of this Corporation shall be CLERMONT PEDIATRICS, P.A.

### ARTICLE II - PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 1755 East Highway 50, Suite A, Clermont, Florida 34711.

### ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is One Thousand (1000) shares of common stock having a par value of One Dollar (\$1.00) per share.

### **ARTICLE IV - GENERAL NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation shall be:

- A. To engage in every phase and aspect of the business of practicing family medicine to or for the benefit of the public that a physician duly licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees and agents of the corporation who are duly licensed under the laws of the State of Florida to practice medicine therein.
- B. To invest the funds of this corporation in real estate, mortgages, stocks, bonds or any other type of investment, and to own real and personal property necessary for the rendering of such professional services.
- C. To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objectives of the corporation enumerated in these Articles of Incorporation or any amendment thereof, and to do any act necessary or incidental to the protection and benefit of the corporation.
- D. It is intended that this corporation may conduct and transact any business lawfully authorized and not prohibited by Chapter 607 and Chapter 621, Florida Statutes, as the same may be from time to time amended.

### ARTICLE V - INDEMNIFICATION

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

### ARTICLE VI - INITIAL REGISTERED OFFICE

### AND REGISTERED AGENT

The initial street address of the registered office of this Corporation in the State of Florida shall be 557 North Wymore Road, Suite 100, Maitland, Florida 32751. The Board of Directors may from time to time move the registered office to any other address in Florida. The name of the initial registered agent of this Corporation at that address is STEVEN H. KANE. The Board of Directors may from time to time designate a new registered agent.

### <u>ARTICLE VIII - INITIAL BOARD OF DIRECTORS</u>

- A. The initial number of directors of this Corporation shall be two (2).
- B. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of this Corporation, but shall never be less than one (1).
