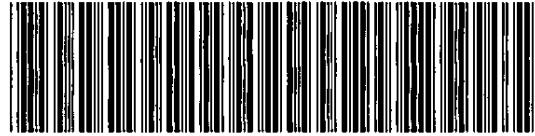



**ARTICLES OF INCORPORATION  
OF  
INTEGRATED INSURANCE INSPECTIONS, INC.**

The undersigned Subscriber to these Articles of Incorporation, a natural person competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of this Corporation is **INTEGRATED INSURANCE INSPECTIONS, INC.**  
The principal and mailing address of this Corporation shall be 614½ Eighth Street North, St. Petersburg, Florida 33701.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence unless dissolved according to law.

**ARTICLE III - PURPOSE**

The purpose for which this Corporation is organized is to engage in any and all lawful business activities permitted under the Laws of the United States and the State of Florida. The Corporation shall have power to do everything necessary, proper, advisable, and convenient for the accomplishment of the purposes hereinafter set forth and to do all other things incidental thereto or connected therewith which are not prohibited by statute or by these Articles of Incorporation.

REYNOLDS, ESQUIRE, who, upon accepting this designation, agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.

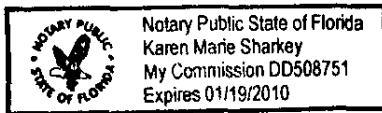
