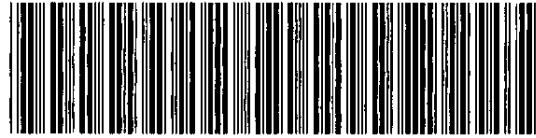

ARTICLES OF INCORPORATION
OF
STRUCTURALS BY P & H, INC.

ARTICLE I

The name of this corporation is **STRUCTURALS BY P & H, INC.**

ARTICLE II

The purpose or purposes for which this corporation is organized is for any purpose permitted under the laws of the United States and under the laws of the State of Florida.

ARTICLE III

This corporation is authorized to issue a maximum of One Hundred (100) shares of stock. The shares of stock authorized shall be common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

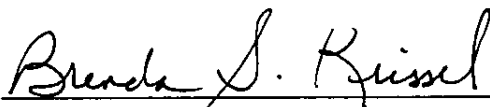

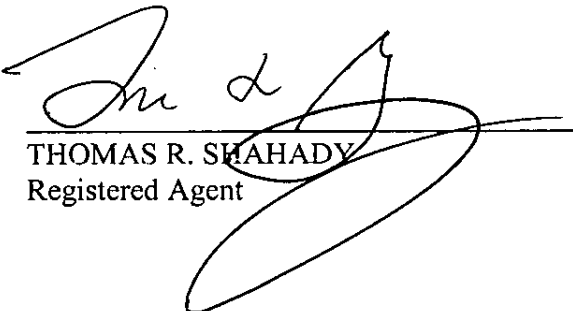
