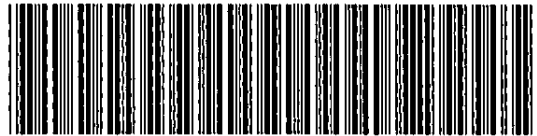

ARTICLE I - NAME

The name of this corporation is Acceptance Title Group, Inc.

ARTICLE II - PRINCIPAL OFFICE
