Maria E. Ataury is *deleted* as Registered Agent of the Corporation.

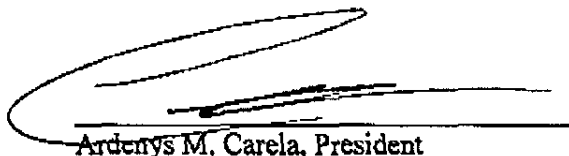
Ardenys M. Carela shall be the new Registered Agent of the corporation at 3850 SW 87th Avenue, Suite 206, Miami, Florida 33165.

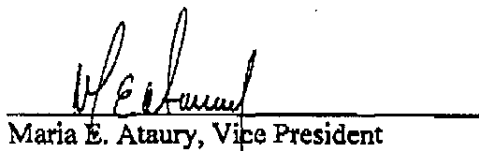
