The following articles of merger (the "Articles of Merger") of Advance Food Service Equipment LLC, a Maine limited liability (the "Merging Corporation"), and Advance Case Parts, Inc., a Florida corporation (the "Surviving Corporation"), have been duly adopted and submitted in accordance with the Florida Business Corporation Act (the "FBCA"), pursuant to Section 607.1105 of the FBCA.

**FIRST: THE SURVIVING PARTY**


