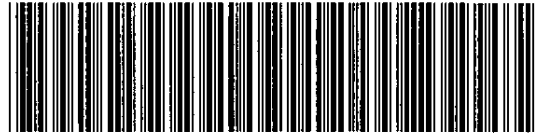

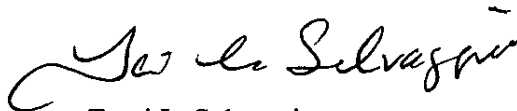

ARTICLE I
Name

The name of this corporation is ADVANCED FIRE CODE SOLUTIONS, INC. and its address is 2318 SW 31st Lane, Cape Coral, Florida 33914.

ARTICLE II
Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III
Capital Stock

This corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

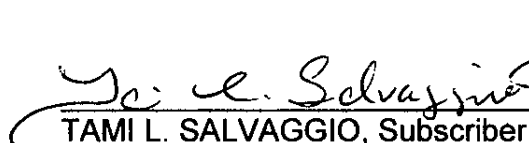
ARTICLE XII
Compensation

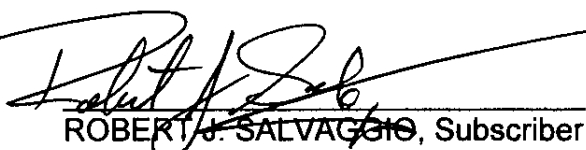
The directors and all other officers of this corporation shall serve without compensation, unless expressly otherwise provided by unanimous vote of the Board of Directors.

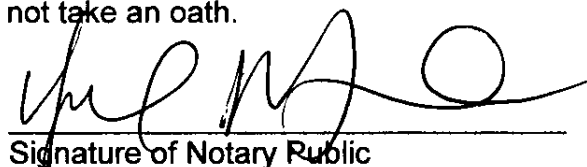

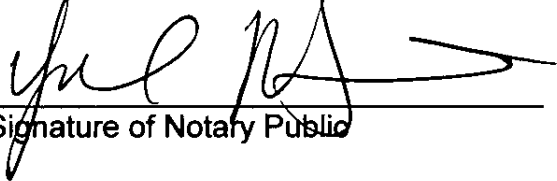
