ARTICLE V-Adoption of Dissolution

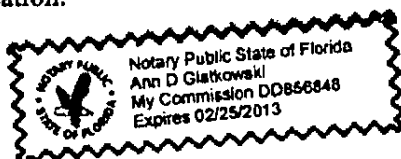

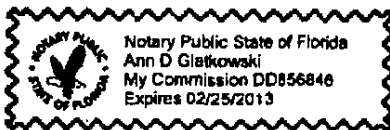

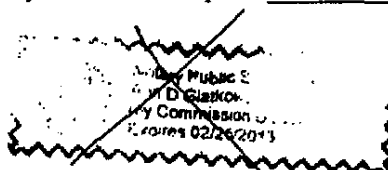
