# ARTICLES OF INCORPORATION OF FREE ENTERPRISE PRESS, INC.

SECRETARY OF STATE . TALLAHASSEE, FLORIDA

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

## ARTICLE I

The name of the corporation ("Corporation") is Free Enterprise Press, Inc.

# ARTICLE II

The existence of the corporation shall begin on November 26, 2007.

#### ARTICLE III

The street address and mailing address of the principal office of the Corporation is 200 Harbor Walk Drive, Unit 255, Punta Gorda, Florida 33950.

#### ARTICLEIV

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares.
