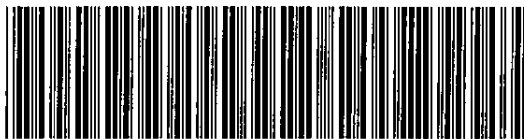

ARTICLE 1

THE NAME OF THE CORPORATION SHALL BE FIELDING HOWELL DICKEY INC.
