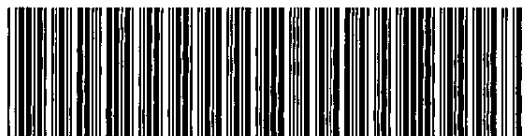

## Articles of Incorporation

Article I. The name of the corporation shall be Alea Butcher Supply Incorporated.  
The corporation will be doing business as Alea Butcher Supplies, Inc.

Article II. The principal place of business and mailing address of the corporation is 5221 NW 26<sup>th</sup> Court, Margate, Florida 33063-1611.

Article III. The purpose of the corporation is to supply retail markets with up-to-date sharpening equipment for the butcher market service to the public.
