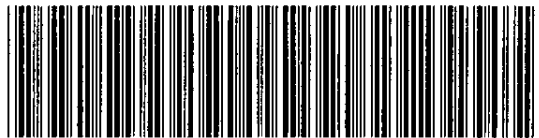

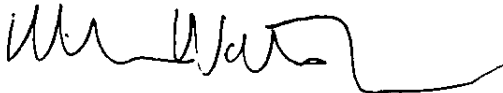

ARTICLE 1: CORPORATE NAME: The name of this corporation is **JOHNNIE'S PRESSURE CLEANING, INC.**

ARTICLE 2: PRINCIPAL OFFICE AND MAILING ADDRESS: The street address of the initial principal office of this corporation is 1000 East Atlantic Blvd., Suite 206J, Pompano Beach, FL 33060, and the initial mailing address of this corporation is 2115 Rock Island Road, Margate, FL 33063.

ARTICLE 3: CORPORATE POWERS: This corporation shall have the power to engage in all transactions permitted by law, and shall otherwise have all powers and may engage in all business permitted by law.

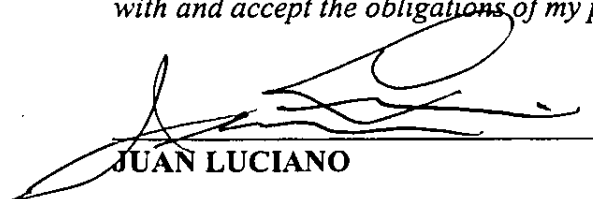
