In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: **Logan Kittler Holdings, Inc.**

ARTICLE II

The street address of the principal office of the Corporation is: 116 White Cap Way, Panama City Beach, FL 32407.

ARTICLE III

This Corporation shall transact its business purposes as a Small Disabled Veteran Owned Company under the name of Logan Kittler Holdings, Inc. and as a company "Doing Business as" (DBA) under separate registry of the DBA name. The general nature of the business to be transacted and carried on by this Corporation and its objects and purposes are to conduct any and all lawful business consistent with the provisions hereinafter set out or provided and it shall have all the powers conferred by the laws of the State of Florida upon corporations as fully and to the same extent as natural persons might or could do in all parts of the world, namely:

To establish, carry on, conduct maintain and otherwise operate a business for conducting and facilitating all manners of business, including real estate transactions for profit, either as a principal or a representative of a principal(s) to a transaction(s).

The foregoing provisions shall be construed as objects in furtherance and not in limitation of the general powers conferred by the laws of the State of Florida and the enumeration in these Articles of specific powers and objects shall not be held to limit or restrict in any manner the powers of this corporation: but this Corporation may do all and everything necessary, suitable or

proper for the accomplishment of any purpose or object, either along or in association with other corporations, limited liability companies, companies, partnerships, proprietorships or individuals, to the same extent and as fully as individuals might or could do as principals, agents, contractors or otherwise.

ARTICLE IV

The initial street address of the Corporation's registered office is: 116 White Cap Way, Panama City Beach, Florida, 32407. The initial registered agent for the Corporation at that address is: **John L. Kittler**.

ARTICLE V

The initial board of directors shall consist of one member. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The name and address of the person who will serve on the initial board of directors is:




