# ARTICLES OF INCORPORATION OF NATIBRO HOLDINGS, INC.

The undersigned, acting as incorporator of NATIBRO HOLDINGS, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

### ARTICLE I. NAME
