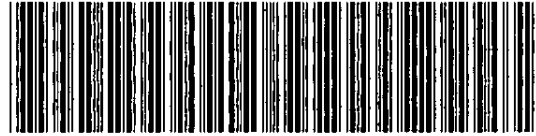

ARTICLE I
Name

The name of the corporation is STRANSKY'S MISSION FARM, INC.

ARTICLE II
Duration


ARTICLE VI




