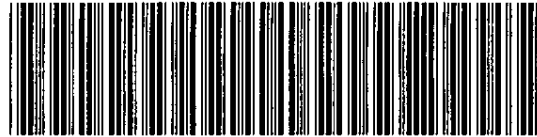



OF

ARTICLE I

Name of Corporation

The name of this corporation is NOEL TRAFFIC SCHOOL INC.

ARTICLE II





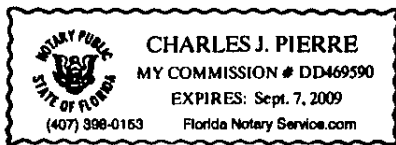
