

**ARTICLES OF INCORPORATION**

The Undersigned hereby adopts the following Articles of incorporation for the purpose of forming a corporation under the law of the state of Florida.

**ARTICLE 1 - Name**

The name of the corporation is STREET BOI ENTERTAINMENT INC.

**ARTICLE 2 - Principal Office**

The principal office of the Corporation is 9481 Highland Oak Dr. Apt. 805 Tampa, FL 33647 and it's mailing address is the same.

**ARTICLE 3 - Commencement and Duration**

The corporation is to commence its corporate existence effective upon filing hereof, and shall exist perpetually thereafter until dissolved according to law

**ARTICLE 4 - Purpose**

The corporation is organized for the purpose of transact any and all lawful Business under the laws of the State of Florida as they may be amended from time to time

**ARTICLE 5 - Initial Business**

1. Publication-Distribution of copies or phonorecords, CD, tapes, video's of a work to the public by sale or other transfer of ownership or by rental, lease, lending or for purposes of public performance, or public display.
2. To secure and register copyrights and trademarks.
3. To own and operate a recording studio.
4. To sign artists to a recording contracts and release a Copyrighted composition.
5. To record and release a Copyrighted composition.
  - a.) Reproduce the copyrighted work in copies or phonorecords. The definition provided by the

1976 Copyright Act.

b.) Prepare derivative works based upon the copyright work according to the 1976 Copyright Act definition.

c.) Distribute copies or phonorecords of the copyrighted work to the public by sale or other transfer of ownership or by rental, lease, or lending.

d.) Perform the copyrighted work publicly, in case of literary, musical, dramatic, and choreographic works, pantomimes, and motion pictures and other audiovisual works.

e.) Display the copyrighted work publicly, in the case of literary, musical, dramatic, and choreographic works, pantomimes.

f.) And pictorial graphic or sculptural works including the individual images of a motion picture or their audiovisual work.

6. Perform as a talent scout in the discovery of new artist in choosing appropriate musical material and in selecting and supervising arrangers, accompanist, studios, and engineers.

7. To own property, enter into contracts and carry on any activity necessary or incidental to the accomplishment of furtherance of the purpose of this Corporation

#### **ARTICLE 6 - Capital Stock**

The Corporation is authorized to issue only one class of shares stock, which shall be, designated Common Stock. The total number of shares the Corporation shall have authority to issue is 1,000 each share to have a par value of \$1.00.

#### **ARTICLE 7 - Preemptive Right**

Each shareholder of the corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the price offered to others, a pro rata portion of any stock of any class that the corporation may issue or sell, whether or not of

unissued shares authorized by the articles of incorporation as originally filed or by any amendment thereof or out of shares of stock of the corporation acquired by it after the issuance thereof.

#### **ARTICLE 8 - Board of Directors**

All corporate powers shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of the board of directors.

The number of directors constituting the initial Board or three. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.

The name and address of the initial directors who shall hold office until their successors, who shall be chosen at the first meeting of the stockholders have qualified, shall be.

#### **ARTICLE 9 - No Personal Liability**

The private property of the stockholders shall not be subject to the payment of corporate debts.

#### **ARTICLE 10 - Indemnification**

The corporation shall indemnify any present or former officer or director, or person exercising powers and duties of a director, to the full extent now or hereafter permitted by law.

#### **ARTICLE 11 - Operating Provisions**

The provisions for the operation, regulations, and management of the business and

internal affairs of the Corporation shall be as set forth in the Bylaws, which may be amended from time to time by a majority vote of a quorum of the Board of Directors.

#### **ARTICLE 12 - Bylaws**

The power to adopt, alters, amend, or repeal bylaws shell be vested in the board of directors and the shareholders, but the board of directors may not alter, amend, or repeal any bylaw adopted by the shareholder if the shareholder provide that the bylaws shell not be altered, amended, or repealed by the board of directors.

#### **ARTICLE 13 - Amendment**

The articles of incorporation may be amended at any time by a vote of the majority of the voting stock of the corporation outstanding, at any regular meeting of the stockholders or at any special meeting of the stockholders called for that purpose.



#### **ARTICLE 15 - Initial Registered Office and Agent**
