

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Weston Lakes Animal Medical Center, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 286 Indian Trace Road Weston, Florida 33326

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
