**ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a professional association under the Professional Services Corporation and Limited Liability Company Act (the "Professional Services Corporation Act"), hereby adopts the following Articles of Incorporation.

**Article I
Name and Duration**

The name of the professional association is: Mapson Law Firm, P.A. The duration of the professional association is perpetual. The effective date upon which this professional association shall come into existence shall be the date these Articles are filed by the Secretary of State.

**Article II
Principal Office**

The address of the principal office and mailing address of the professional association in the State of Florida is 10151 Deerwood Park Boulevard, Building 200, Suite 250, Jacksonville, Florida 32256.

**Article III
Corporate Purposes, Powers and Rights**

The general purposes for which this professional association is organized shall be:

1. To render professional legal services to the general public, and to do all things in connection therewith that are customarily done by lawyers under the laws of the State of Florida.

2. In furtherance of its corporate purposes, the professional association shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Professional Services Corporation Act.

Article IV
Capital Stock

The maximum number of shares of stock that this professional association is authorized to have outstanding at any one time is one thousand (1,000) shares having \$.01 par value.

Article V
Shareholder Restrictions

No one other than an individual who is duly licensed or legally authorized to render legal services in the State of Florida may own stock of this professional association. No shareholder of this professional association shall enter into a voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his or her stock. Any stockholder who becomes legally disqualified to render legal services shall sever all employment with and financial interest in the professional association. No shareholder shall transfer any shares of stock of the professional association, except to another individual who is eligible to be a shareholder of the professional association.

Article VI
Registered Office and Agent

The street address of the initial registered office of the professional association is 908 Park Forest Lane, Jacksonville, Florida 32211, and the name of the registered agent of this professional association at that address is Charles E. Mapson.

Article VII
Bylaws

The power to adopt, amend or repeal bylaws for management of the professional association shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to the amendment or repeal by the Board of Directors.

Article VIII
Incorporator

Article IX
Amendment

The professional association reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and any right conferred upon the shareholders is subject to this reservation.
