ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned incorporator, for the purpose of forming a professional association under the Professional Services Corporation and Limited Liability Company Act (the "Professional Services Corporation Act"), hereby adopts the following Articles of Incorporation.

Article I Name and Duration
