

ARTICLES OF INCORPORATION OF CYPRIAN HILL, INC.



Article 1

Name. The name of this Corporation is CYPRIAN HILL, INC.

Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 2850 S.E. Third Court, Ocala, Florida, 34471.
