ARTICLES OF INCORPORATION SECRETARY OF STATE TALLAMASSEE, FLORIDA

FOR

BLUE SKY GLASS CONCEPTS, INC.

The undersigned, desiring to form a corporation under and by virtue of the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit, states as follows:

ARTICLE I Name and Address of Corporation

The name of this corporation shall be BLUE SKY GLASS CONCEPTS, INC., and the principal business and mailing address is 3367 Buffam Place, Casselberry, Florida 32707.

ARTICLE II Objects and Purposes of Corporation

The objects and purposes of the corporation and the general nature of the business or businesses to be transacted shall be:

- To engage in any lawful businesses permitted or allowed under the Florida General Corporation Act.
- To make and enter into all contracts necessary and proper for the conduct of 2. its business or businesses.
- To borrow money from any person, firm, or corporation; to issue bonds, 3. debentures, or obligations of this corporation from time to time for any of the objects or purposes of the corporation; and to secure same by mortgage, pledge or by any other lawful means.

It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

Every shareholder of the corporation, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE X Annual Meeting of Shareholders

- 1.
