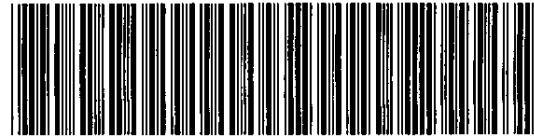

The corporation is authorized to issue 10,000,000 shares of voting Class A common stock at no par value per share and 1,000,000 shares of non-voting Class B common stock at no par value per share. Each share of Class A common stock and Class B common stock shall entitle the holder thereof to all of the same rights of a common stock holder of the corporation, except that only Class A common stock shall entitle the holder thereof to vote upon actions and decisions for which shareholder approval shall be required or permitted.
