

ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Certified Pilot Car & Escort Service, Inc.

ARTICLE II

This corporation shall have perpetual existence. The general nature of the corporate business to be transacted is to promote the medical coding profession and the corporation may engage in transaction of any or all lawful businesses for which corporations may be incorporated under the laws of the State of Florida.
