The undersigned incorporator of Triple S&P, Inc., in compliance with Chapters 607 and 621, Florida Statutes, for the purpose of forming a "for profit" corporation, hereby certifies the following:

ARTICLE I. NAME

The name of the corporation is: Triple S&P, Inc.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the initial principal office and mailing address of the corporation is 707 West Azeele Street, Tampa, Florida 33606.

ARTICLE III. CAPITAL STOCK
