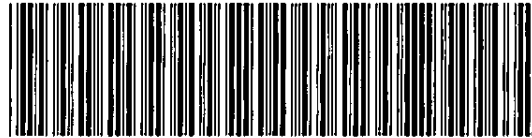

ARTICLE I

NAME

NATURE OF BUSINESS

These Articles of Incorporation shall be effective upon filing with the Secretary of State of Florida.

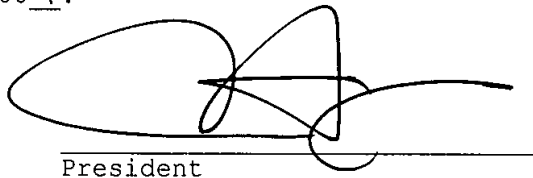
## ARTICLE X

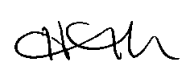

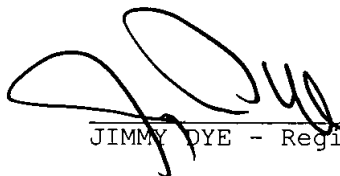
