The undersigned natural person of the age of twenty-one (21) years or more, acting as incorporator of a corporation under the Florida Business Corporation Act, Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE 1 - NAME

The name of this Corporation is John Judge, Inc. (hereinafter called the "Corporation")

ARTICLE 11 - EFFECTIVE DATE AND DURATION

The Corporation will have an effective date of December 18, 2007 and will exist for a perpetual period.

ARTICLE 111 - PURPOSE

The Corporation is being formed for the purpose of offering Housekeeping services

ARTICLE 1V - CAPITAL STOCK

The Corporation is authorized to issue one thousand shares (1,000) shares of common stock..

ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE

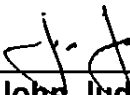

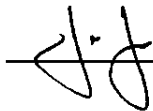
