#### ARTICLES OF INCORPORATION

OF

#### D. & E. HANEY ENTERPRISES, INC.

The undersigned, being of legal age and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

## ARTICLE I. NAME

The name of this Corporation shall be: D. & E. HANEY ENTERPRISES, INC.

## ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation shall commence corporate existence upon filing, and shall have perpetual existence unless sooner dissolved according to law.

#### ARTICLE III. PURPOSES AND GENERAL POWERS

The general purpose of this Corporation shall be to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida. ## ARTICLE XII. LIMITED LIABILITY OF SHAREHOLDERS

The private property of the shareholders shall not be subject to payment of the Corporation's debts to any extent.

## ARTICLE XIII. AMENDMENT
