We, the undersigned, do hereby associate ourselves together and subscribe These Articles of incorporation for the purpose of forming corporation under the laws of the State of Florida, Chapter 607 subject to the following provisions:

ARTICLE ONE

The name of the corporation shall be:

ARTICLE TWO

This corporation shall have perpetual existence and may engage in any activity or business permitted under the law of the United States and of the State of Florida.
