ARTICLE ONE

The name of this corporation is ROCKWALL DRYWALL, INC. and the mailing address of the corporation shall be 454 Crossfield Circle, Naples, Florida 34104.

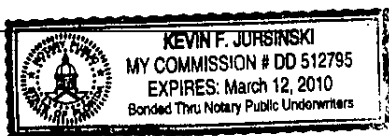

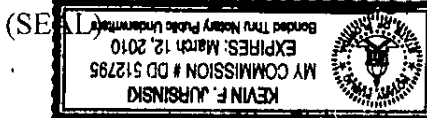
