#### ARTICLES OF INCORPORATION **OF** BROOKS PROPERTIES SOUTH MANAGEMENT CORP.

THE UNDERSIGNED, acting as sole incorporator of a corporation to be formed under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the corporation (the "Corporation") is:

SECOND: The principal office of the Corporation is:

The rights of the Voting Stock and the Non-Voting Stock shall be identical, except that the Non-Voting Stock shall not be entitled to vote other than as required by law.
